Whereas, Tentative Seniority List of Labour Inspectors/ Caretaker/Assistant Labour Welfare Officers / Supervisors/ Head Assistants/Senior Assistants and Junior Assistants was circulated vide circular issued under endorsement No:- LC/Estt/Seniority/2017/469-78 dated:- 19-05-2017 for filing objections if any, within 15 days positively from the date of issuance of the said circular. Subsequently the period for filing objections was extended for 15 days more i.e. up to 28-06-2017 vide communication No. LC/Estt/Seniority/2017/577-85 dated 13-06-2017;

Whereas, Deputy Labour Commissioner, Jammu vide her letter No. DLC/J/2017/92/425 dated 29-05-2017 forwarded the representation of Sh. Roshan Lal, Labour Inspector looking after the work of Labour Officer Circle-IV Jammu for not showing him as Incharge Labour Officer in the category of Labour Inspectors;

Whereas, in pursuance to this office order No. 44-LC of 2015 dated 12-03-2015 Shri Roshan Lal Labour Inspector Circle-II Jammu was transferred and asked to look after the work of Labour Officer Circle-IV Jammu till further orders. This order specifically provided that, "**Sh. Roshan Lal Labour Inspector Circle-II, Jammu is transferred to look after the work of labour officer Circle-IV, Jammu, till further orders. This arrangement is temporary/reversible and does not confer any preferential right upon the incumbent to hold the post in case not found fit for promotion, under rules**". Since, the official was neither promoted nor placed as incharge Labour officer, his claim is not based on facts and is as such rejected.
